## Once you have made satisfactory arrangements and have cleared your default status:

- 1. Complete this form.
- 2. Attach documentation <u>from the holder of your loan</u> confirming resolution of default status, either by paying the loan in full (including consolidation) or by making satisfactory repayment arrangements (six consecutive, full, voluntary payments on time). **NOTE: You must make a total of nine consecutive, full, voluntary payments on time to resolve the default status completely.**
